Subject:- For intervene in the matter of convicted Dera Sirsa Head Gurmeet Ram Raheem Singh of misusing his political approach and high end links thereby, canceling the parole granted to the accused on medical grounds since, the same is being misused by the above said convicted accused.

Respected Sir,

It is most humbly submitted that I Anshul Chhatrapati son of late Sh. Ram Chander Chhatrapati, I am a resident of house no.688 B, sector 20 Huda, Sirsa, Haryana. I am the complainant in case No.RC-10-S/2003 registered against the above said accused namely Gurmeet Ram Raheem Singh for offences under Section 302, 120-B of IPC for the charges of murder of Ram chandar Chhatrapati, and the accused was found guilty and subsequently convicted for the said offences on 11.01.2019 and was sentenced to undergo life imprisonment.

1. That apart from the above said case RC10-S/2003, the above said accused has also been convicted in RC 05-S/2002 for offences under Section 376, 506 of IPC for committing of rape upon two Sadhvi's of his own Ashram on 25.08.2017 and was sentenced to undergo rigorous imprisonment for a period of 10 years for each rape case i.e. 20 years for both cases.

Even otherwise the trial against the above said accused is pending before the Special Court, CBI, Panchkula in RC 08-S/2003 under Section 302, 120-B of IPC more popularly termed as 'Ranjit Singh murder case' and

another case for castration of approximately 400 plus Sadhus for offences under Section 326, 467 & 468 of IPC, however, the details of this case are not readily available with the present applicant.

2. That by misusing his political approach and high end links, the above said accused has been obtaining a parole one after another thereby, rendering the process of law nullified and mocking the process of natural justice.

The accused initially succeeded in obtaining a parole from the administration on 24.10.2020 for a day. Thereafter, not after a long period of time, the above said accused was once again granted parole on 21.05.2021 by citing his desire to go meet his ailing mother, who was allegedly lying in hospital owing to her serious medical conditions. However, it is worthwhile to mention over here that the accused did not even pay a single visit to any hospital in or around the vicinity of the State of Haryana or Punjab and rather disappeared for days together. The applicant from reliable sources has come to learn that the above said accused was rather kept at someone farm house at Manesar district Gurugram where he conducted various high end meetings with his associates and staff members of the Ashram i.e. Dera management of Dera Sacha Sauda Sirsa.

3. That in furtherance of his chicanery and high handedness, the accused namely Gurmeet Ram Raheem Singh once again in alleged connivance with the jail authorities staged a high end drama thereby, showcasing depletion in the health levels of the accused.

On the basis of the same, the accused was once again granted a parole on medical grounds on 06.06.2021 and was immediately rushed to the Post Graduate Institute of Medical Education Research, Rohtak wherein, the accused was to be subjected to a rapid antigen test for Covid-19 but the

accused for extraneous reasons started throwing tantrums and denied to give sample to hospital thereby, demanding to be treated at a private medical facility at Medanta Hospital, Gurugram wherein after his medical examination, he was allegedly diagnosed to be Covid positive and was immediately isolated.


4. It is pertinent to mention over here that the accused Gurmeet Ram Raheem Singh further refused to accept any medical attention or assistance from the trained medical staff of the Hospital and rather insisted that his devotee namely Honeypreet Kaur be deputed to assist and take care of him while in isolation.
5. That it is a matter of record and a known fact that the said accused has been kept in solitary confinement at the Jail premises and as such, it becomes highly unlikely that the accused would contact Covid-19 from within the jail. Also the fact that the accused refused to be treated at a critically and national acclaimed medical facility namely PGI, Rohtak and rather insisted to be treated at a private facility raises various eyebrows of doubt on the intent of the accused.
6. That it is also worthwhile to mention over here that the above said Honeypreet Kaur, who has been deployed as help and medical assistance on the specific asking of the accused was the perpetrator and prime accused of the violence that took place at Panchkula, Haryana on 25.08.2017, after the said accused was under trail by the Ld. Special Court, CBI, Panchkula, wherein around 40 people including various police officials and innocent civilians lost their lives and hundreds of others were injured and suffered loss of income and property at the hands of the goons of the said accused.

7. The applicant apprehends that this pattern of seeking paroles one after the other, might be a part of a devious plan and might turn up to be dangerous and life threatening to the general public at large, since, the accused has a history of creating public nuisance in large.
8. That is case no. No.RC-10-C/2003 parole of other co accused Krishan Lal dismissed by Hon'ble Punjab and Haryana High court even after reason of his mother's death.
9. That Hon'ble Punjab and Haryana High court takes very serious note after Panchkula violence and issued directions to administration not to act upon political persons.
10. That the Hon'ble Supreme Court of India has time and again insisted that the concession of parole is to be granted after due consideration of the material and facts on record and should not be treated as a handout for the rich and influential.

It is therefore most respectfully prayed that the parole granted to the above said accused on 06.06.2021 on medical grounds may immediately be terminated and the accused be ordered to return to the isolation facility at the jail premises and if any kind of medical assistance is required by the accused, the same may be arranged within the premises of jail where he is withheld.
